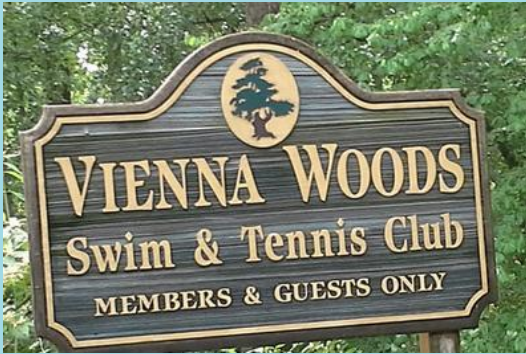


VW Newsletter: January 2024



Message from the President of the VW Board of Directors

Greetings and Happy New Year!

I trust everyone had a great holiday season and now are recharged for a spectacular 2024!

The current cold streak makes us crave the warmth of Summer and the pool opening... and the good thing is we are a mere 4 plus months away from opening day! I am the eternal optimist, so I hope you can enjoy my positive outlook.

Great things await our 2024 season! As a reminder, at the fall stockholders meeting, our membership approved an increase of \$500 in dues for the next two seasons (2024 and 2025). So here's the recap:

- Dues will be a total of \$1195 for the next two seasons
- Non-use fee will be \$600
- Stock price will increase to \$2200 in November 2024 (\$500 increase from \$1700)
- 2024 rentals to families on waitlist will be \$1,095

**Please note that the dues can be paid at any time going forward. We strongly encourage getting ahead of the payments to make it easier for everyone. We kindly ask that the dues of \$695 and \$500 increase be paid in full by March 5th, 2024. We appreciate your ability to adhere to this timeframe.

These increases are earmarked for capital improvements at the pool with the major one being the complete overhaul of the baby pool and the area around it. The rental fee will be adjusted as well to reflect the increase. Below are renderings of the upcoming renovation.

It is our hope that this renovation will be completed either before or during the 2024 season. We will update you on our progress during the winter months.

Again, these improvements are for our future generations to enjoy and we greatly appreciate everyone shouldering the increase to keep our facilities the best in the area. If you should have questions regarding the dues increases, please reach out to me directly and I will be happy to answer them.
